RAISED PLATFORMS / STAIRWAYS	
All stairways with more than 4 rises, are equipped with a hand railing and slip resistant.	
Guardrails are installed on surfaces higher than 4 ft.	
Check that top-rails and mid-rails are made of 2 x 4 planks.	
Check that material on elevated surfaces is piled, stacked, or racked in a manner to prevent the material from falling, collapsing, rolling, or spreading.	
Check that there is no storage under platforms or stages. Chicken wire may be used to prevent storage under stage platforms.	
All lifts require Fall Protection be worn at all times.	
Control zones and/or hard hats are required when there is overhead work. Sign accordingly.	
HAZARDOUS MATERIALS	
SDS are available for all chemicals and hazardous materials and labelled in accordance with WHMIS.	
Stored in approved containers without leaks.	
Spray booths and ventilation operational and in use.	
If spraying is done outside of spray booth, a well-ventilated, signed control zone is clearly established and used.
